#### Summary

Dr. Amsel serves as an expert witness in matters related to psychiatry and the law, with a focus on PTSD, Psychological Aspects of Personal Injury, Psychiatric Malpractice, Suicide and Wrongful Death, Prolonged Grief, Psychiatric Injury due to Social Media, Medical Decision Making, and Hospital Psychiatric Care. Dr. Amsel's expertise around the interface of legal and psychiatric issues is based on 28 years of experience on the faculty of Columbia University involved with clinical practice, emergency room psychiatry, academic psychiatry, research, and public health. As an expert in the effects of traumatic experiences, after 9/11 Dr. Amsel co-directed the Trauma Studies and Services Division at the New York State Psychiatric Institute at Columbia University, where he worked extensively with victims of 9/11 and their families, and researched the effects of the 9/11 attacks on survivors and first responders, and in trained other clinicians about PTSD and Prolonged Grief. Dr. Amsel was one of the early champions of applying Decision Science, Game Theory and Behavioral Economics to medical decision making and in Forensic Epidemiology. He has applied these techniques to the interface of psychiatry and the law. He brings his extensive clinical and research expertise to a variety of complex legal issues involving psychiatry.
